INTEREST RATES and INTEREST CHARGES:			
Annual Percentage Rate (APR) for Purchases, Cash Advances & Balance Transfers	Visa Platinum 2.9% Introductory APR for six months. After that, your Standard APR will be 8.65%, 9.65%, 10.65%, 13.65% or 16.65% depending on your credit history. This APR will vary with the market based on the Prime Rate.	Visa Signature / Visa Platinum Rewards 2.9% Introductory APR for six months. After that, your Standard APR will be 10.65%, 11.65%, 12.65%, 15.65% or 18.00% depending on your credit history. Penalty APR and When it Applies	18% This APR may be applied to your account if you make a payment that is late 60 days or more. How Long Will the Penalty APR Apply? Paying Interest	Your due date is at least 25 days after the close of each billing cycle. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.
